**NOTIFICATION**

In exercise of the powers conferred by clause (a) of Sub-Section (1) of Section 9 of the Indian Stamp Act, 1899 (Central Act II of 1899), the Governor of Andhra Pradesh hereby reduces the Stamp Duty chargeable @ 0.5% on the Documents under article 7(a) and (b) of the Schedule IA of the Indian Stamp Act, 1899, for Deposit of Title Deeds and Pawn, Pledge or Hypothecation to be executed by the Small Scale Industries subject to a maximum of Rs. 1,000/-.
