The following notification will be published in the Andhra Pradesh
Extraordinary Gazette dated:28.05.2001.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 69 of the
Registration Act, 1908 (Central Act 16 of 1908), the Governor of Andhra Pradesh
hereby makes the following amendments to the Registration Rules, 1908.

These amendments shall be deemed to have come into force with effect from
5th February, 1999.

AMENDMENT

(i) In the said rules, in rule 232 after sub-rule (6), the following sub-rule shall be
added, namely:-

“(7) A complete working set of CARD Hardware System, with a set of
instructions to instal the same shall be preserved in the Central Archival
Room to cover the risk against technological obsolescence, whenever major
hardware architectural changes occur. One set of the new hardware should
be preserved in the Central Archival Room for future use”.

(ii) In rule 233 after sub-rule (3), the following sub-rule shall be added namely:-

"(4) To deal with the situation arising on account of,-

- (a) documents missing in C.Ds., soft copy not found in the system i.e., hard disk;
- (b) documents scanned and archived with poor quality image;
- (c) Images of documents are missing;
- (d) documents scanned and archived in irregular order; and
- (e) documents scanned and archived with wrong documents.

Note:- A special volume shall be opened by obtaining the permission of the District Registrar in writing and all such documents mentioned in sub-rule (4) above shall be registered manually and the reasons duly recorded in the minute book.
