ORDER

1. In the G.O. first read above, Government in Information Technology and Communications Department have issued guidelines for financing e-Governance projects and advised to constitute a Committee headed by the concerned Head of the Department with representatives of concerned administrative department and Finance Department.

2. According, to the G.O. second read above, a Committee was constituted with the Commissioner and Inspector General of Registration and Stamps as Chairman and the Deputy Secretary, Finance and Additional Secretary, Revenue Department as Members to study and submit a report regarding levy of service charges for the services rendered under the CARD Project.

3. The Committee has accordingly examined the service standards maintained in respect of each service delivered through CARD Project and has submitted a report duly proposing levy of service charges and prescribed the procedure for depositing and utilization of the funds collected through levying service charges for maintenance of CARD project.

4. The Commissioner and Inspector General of Registration and Stamps, after taking into consideration of the minutes of the Meeting of the Committee, in his letter third read above, has proposed to levy the following Service Charges to be collected from the citizens:

| 7) | For each registration of document through CARD In Book-I i.e., sales, Exchange, partition, Release, Gift Settlement etc., the total chargeable value Exceeds Rs.50, 000/-(up to 10 sheets) | Rs.95.00 |
| 8) | For each extra <u>scanned sheet that</u> exceeds 10 sheets in a single document. | Rs.5.00 |

5. The Commissioner and Inspector General of Registration and Stamps has also proposed the following operational procedure with regard to P.D.Account:

- 1) Commissioner and Inspector General of Registration and Stamps and District Registrar should have drawing accounts in the P.D.Account.
- 2) Commissioner and Inspector General of Registration and Stamps is empowered to pool up all the money at District Registrar 's, or Commissioner and Inspector General of Registration and Stamps account before any expenditure is incurred.
- 3) Departmental officers only with the authorization of the Head of the Department can incur expenditure.

6. Government after careful examination of the matter approves the proposal of the Commissioner and Inspector General of Registration and Stamps for levying service charges and to adopt the operational procedure with regard to P.D.Account. The levy of the above User Charges would be justified, as the citizens would receive services of higher quality under the computerised system as against the manual system. Government hereby accord permission to the Commissioner and Inspector General of Registration and Stamps to levy the Service Charges and to adopt the operational procedure with regard to P.D. Account as mentioned at paras 4 and 5 above, with immediate effect.
